## ATTIRE

Soft spikes are required.

Display good judgement regarding attire. Any person not adhering to the golf attire standards will not be permitted to play in the tournament, and entry fees will not be refunded.

- Appropriate shorts are acceptable. If shorts are worn, they must be in good taste. Cutoffs, blue jeans, jogging shorts, short shorts or swim trunks are not acceptable.
- Players must wear shirts at all times. "Shirts" are not interpreted to include underwear or t-shirts. All shirts must have collars. "Muscle shirts" are not acceptable.

## CONDITIONS

The Miracle Pro-Am Golf Tournament Committee reserves the right to alter any of the conditions and schedules herein. The decision of the tournament committee in any matter shall be final. The right to reject any entry also is reserved, in which case the entry fee will be refunded. In the event that the Miracle Pro-Am Golf Tournament must be cancelled due to course closure or hazardous weather conditions, the fee for tournament registration will not be refunded. Substitute activities will be scheduled, providing interaction with the visiting professionals and tournament players. The scheduled dinner and program will remain unaffected.
