

Medicare Part D members, this is for you!

There have been some changes regarding prior authorizations and opioids. A prior authorization means your doctor must check with us first before prescribing opioids. The new guidelines are listed below as follows:

- You will require prior authorization if it's been 120 days or more since you've last taken opioids and your new prescription exceeds seven days of medication.
- You will require prior authorization or a pharmacist override at point of sale if you're receiving opioids and benzodiazepines from two or more providers.
- You will require prior authorization or a pharmacist override at point of sale if you're receiving multiple long-acting opioids from two or more providers.
- You may be restricted to specific regimens, providers and/or pharmacies if you show patterns of overusing opioids and benzodiazepines.

Attend your annual well visit

Mail your form by December 31, 2019

You must mail your signed and completed form before the end of the year. When your assessment is complete, and your form is received, you will have earned the \$25 Walmart gift card. Expect six to eight weeks for processing and delivery.

- Do not provide your name, Social Security Number, date of birth or any other personal information
