I. Policy: Wearable Cardioverter Defibrillators and Automatic External Defibrillators

II. Purpose/Objective:

To provide a policy of coverage regarding Wearable Cardioverter Defibrillators and Automatic External Defibrillators

V. Additional Definitions

Medical Necessity or Medically Necessary means Covered Services rendered by a Health Care Provider that the Plan determines are:

- a. appropriate for the symptoms and diagnosis or treatment of the Member's condition, illness, disease or injury:
- provided for the diagnosis, and the direct care and treatment of the Member's condition, illness disease or injury;
- in accordance with current standards of good medical treatment practiced by the general medical community.
- d. not primarily for the convenience of the Member, or the Member's Health Care Provider; and
- e. the most appropriate source or level of service that can safely be provided to the Member. When applied to hospitalization, this further means that the Member requires acute care as an inpatient due to the nature of the services rendered or the Member's condition, and the Member cannot receive safe or adequate care as an outpatient.

Medicaid Business Segment

Medically Necessary — A service, item, procedure, or level of care that is necessary for the proper treatment or management of an illness, injury, or disability is one that:

- Will, or is reasonably expected to, prevent the onset of an illness, condition, injury or disability.
- Will, or is reasonably expected to, reduce or ameliorate the physical, mental or developmental effects of an illness, condition, injury or disability.

Will assist the Member to achieve or maintain maximum functional capacity in performing daily activities, taking
into account both the functional capacity of the Member and those functional capacities that are appropriate for
Members of the same age

DEFINITION:

Wearable Cardioverter Defibrillator (i.e. LifeVest) monitors electrocardiogram (ECG) changes through a programmable microprocessor-based device and an electrode belt containing non-adhesive electrodes integrated into the vest. If a life-threatening arrhythmia is detected, the non-adhesive therapeutic electrodes release a conductive gel to the skin and deliver a shock to the heart.

Automatic External Defibrillators is a portable automatic device used to restore normal cardiac rhythms to patients in cardiac arrest. An AED is applied outside the body. It automatically analyzes the patient's heart rhythm and advises the rescuer whether or not a shock is needed to restore a normal heartbeat. They are often found in public places.

Geisinger Health Plan requires prior authorization through Cohere for Cardiology services for members enrolled in its Commercial HMO and PPO, Medicare Advantage.
