To provide a policy of coverage regarding Computerized Cognitive Health Assessment Systems

Commercial

Medicare

V. Additional Definitions

Medical Necessity or Medically Necessary means Covered Services rendered by a Health Care Provider that the Plan determines are:

- a. appropriate for the symptoms and diagnosis or treatment of the Member's condition, illness, disease or injury;
- b. provided for the diagnosis, and the direct care and treatment of the Member's condition, illness disease or injury;
- c. in accordance with current standards of good medical treatment practiced by the general medical community.
- d. not primarily for the convenience of the Member, or the Member's Health Care Provider; and
- e. the most appropriate source or level of service that can safely be provided to the Member. When applied to hospitalization, this further means that the Member requires acute care as an inpatient due to the nature of the services rendered or the Member's condition, and the Member cannot receive safe or adequate care as an outpatient.

Medicaid Business Segment

Medically Necessary — A service, item, procedure, or level of care that is necessary for the proper treatment or management of an illness, injury, or disability is one that:

- Will, or is reasonably expected to, prevent the onset of an illness, condition, injury or disability.
- Will, or is reasonably expected to, reduce or ameliorate the physical, mental or developmental effects of an illness, condition, injury or disability.
- Will assist the Member to achieve or maintain maximum functional capacity in performing daily activities, taking into account both the functional capacity of the Member and those functional capacities that are appropriate for Members of the same age

DESCRIPTION:

Computerized Cognitive Health Assessment Systems have been proposed for use in assessing cognitive function of patients with a variety of neurological and mental health conditions including but not limited to mild cognitive impairment, dementia, traumatic brain injury, Parkinson's disease, Schizophrenia, and concussion management.

Examples of computerized cognitive health assessments include, but not limited to:

- Mindstreams® Cognitive Health Assessment (NeuroTrax, Newark, NJ)
- Cambridge Neuropsychological Testing (CANTAB®) (Cambridge Cognition LTD, Cambridge, UK)
- CNS Vital Signs® (CNS Vital Signs, LLC, Chapel Hill, NC)
- Computer Administered Neuropsychological Screen for Mild Cognitive Impairment (CANS-MCI®) (Screen, INC., Seattle, WA).
- Cognivue® (Victor, NY)
- BrainCare™ (NeuroTrax, Medina, New York)

EXCLUSIONS:

The Plan does **NOT** provide coverage for Computerized Cognitive Health Assessment Systems, including but not limited to Mindstreams™, for use as a screening, evaluation and/or assessment tool as an alternative to traditional neuropsychological testing because it is considered **unproven**. The Geisinger Technology Assessment Committee evaluated this technology and concluded that there is insufficient evidence in the peer-reviewed published medical literature to establish the effectiveness of this test on health outcomes when compared to established tests or technologies.

The Plan does **NOT** provide coverage for Computerized Cognitive Health Assessment testing for any indication including but not limited to sporting event field assessment of concussion or closed head injury because it is **considered unproven**. There is insufficient evidence in the peer-reviewed published medical literature to establish the effectiveness of this test on health outcomes when compared to established tests or technologies.

Medicaid Business Segment:

Any requests for services, that do not meet criteria set in the PARP, may be evaluated on a case by case basis.

LINE OF BUSINESS:

Eligibility and contract specific benefits, limitations and/or exclusions will apply. Coverage statements found in the line of business specific benefit document will supersede this policy. For Medicare, applicable LCD's and NCD's will supercede this policy. For PA Medicaid Business segment, this policy applies as written.
