Attention Secure Rx plan members: update on over-the-counter medications

Effective April, 1 2016, there are changes to the way you purchase your over-the-counter (OTC) medication and supplies. You should have received a debit card in the mail with instructions for use. This card can be used like a regular credit or debit card for approved OTC items at a participating location. At the beginning of each calendar quarter (every three months), Geisinger Gold will apply a balance for you to use on approved OTC items.



Participating locations include Dollar General, Family Dollar, CVS/Pharmacy, Rite Aid, Walgreens* and Walmart. A list of eligible and non-eligible items will be included with your new card.

**Please note, Walgreens is not a part of Geisinger Gold's Medicare Prescription Drug Coverage (Part D) pharmacy network. Any prescriptions filled at a Walgreen's will not be covered by your benefits. Only OTC items are covered.*
