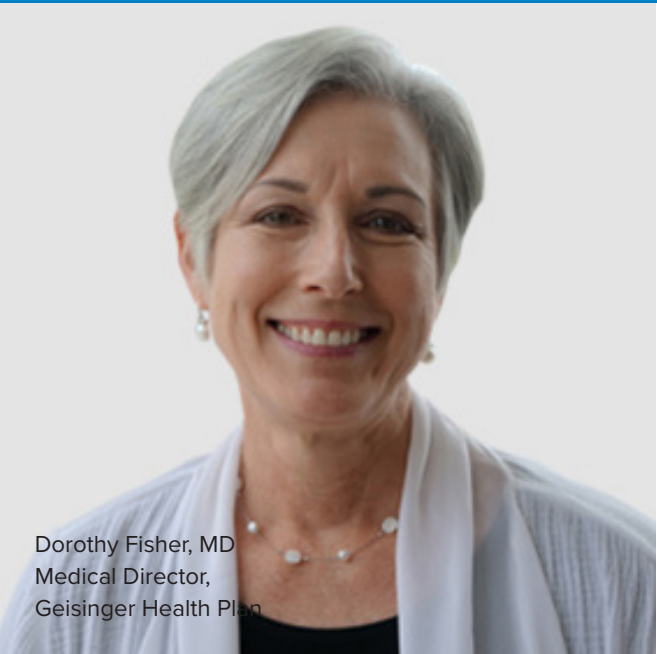

- Data feeds created with GHP assistance — lab, EMR or into health information exchange (HIE)
- Direct remote access (DRA) with local printing
- Participation in KeyHIE

Alternative ways to share medical record data based on your capabilities

- Web portal
- Encrypted flash drives or ironkeys
- FedEx or mail
- GHP-provided human resource — embedded, onsite, or designated retriever
