Frequently asked questions

Q: When will I receive my gift card reward?

A: The rewards program is based on claims we receive from your provider. It can take up to 16 weeks to process your claim, prepare your reward and mail your gift card to you. We mail gift cards once per month.

Q: If I earn multiple gift cards/amounts, will I be paid the total amount all at once?

A: The gift card rewards are not cumulative. They are fulfilled and sent to you on a monthly basis, so you will receive separate gift cards for each screening you complete.

Q: How do I choose one of the three colorectal cancer screening options that is right for me?

A: You have several options for colorectal cancer screening. If you have questions, you can speak to your doctor about what he or she recommends. Below are descriptions of each screening:

FIT - Stool testing that screens for blood in the stool. Non-invasive and can be completed in your own home. Needs to be completed yearly.

Cologuard - Stool testing kit that screens for blood and altered DNA. Non-invasive and can be completed in your own home. Needs to be completed every 3 years.

Colonoscopy - Evaluates/detects changes and abnormalities in the large intestine and rectum. Invasive screening completed by a surgeon. Needs to be completed every 10 years or more often if abnormal.

Q: I had my Annual Physical. Is that the same thing as the Annual Wellness Visit needed to earn my gift card reward?

A: No, an Annual Wellness Visit (AWV) is a special visit unlike an annual physical exam. The AWV can be completed by your primary care provider or another member of your healthcare team. You will receive a personalized prevention plan based on your health and wellness needs. In order to earn your reward, you will need to have an AWV. Q. I had one (or more) of the recommended screenings this year, but I have not had an Annual Wellness Visit (AWV) exam yet. Am I still eligible for the reward?

A. Yes. Once you complete your AWV, you will receive all rewards for any qualifying screenings you completed during calendar year 2021. If you've already completed your AWV this year, you are now eligible to earn rewards for any other screenings you may be qualified for.
