Telehealth: More than physician visits

A Geisinger study found that a remote support program helped decrease blood pressure — meaning new technology can help patients manage their chronic conditions

A research team led by Geisinger nephrologist Alexander Chang, MD, enrolled two groups of patients with high blood pressure in a remote support program delivered through web-based applications. Both groups were provided lifestyle guidance from the American Heart Association, and one group participated in weekly calls with a dietitian.

Over the course of 12 weeks, the two groups saw a similar reduction in 24-hour systolic blood pressure. The group with dietitian support showed a greater reduction in systolic blood pressure while asleep, as well as increased selfreported physical activity. etter dietary quality and more weight loss than t group using remote support alone.
